## Exhibition Rules and Regulations

### 1. Application and Payment

- A. All applications are to be submitted to the office of the **Managing Director or Official Representative of Ozzie Trading** in writing (see the application form).
- B. First Payment: 50% of the total participation fees shall be paid within seven (7) days of signing this contract document.
- C. Only receipt of first payment and completed application form confirms the exhibitor's participation and placement location. Completing the application form without settling the first payment means the exhibitor's chosen placement and location will not be guaranteed. In case of no first payment during application, the exhibitor will be placed on a waiting list without a specified placement and its placement choice will be treated as vacant.
- D. Final Payment: The remaining 50% of the full payment shall be finalized **no later than 22 Jan 2018**.

### 3. Exhibition Space Placement and Allocation

- A. Up on signing of this application form and settlement of first payment, exhibitors shall book their preferred exhibition space and placement by use of the floor plan of the event.
- B. The final exhibition space placement shall be allocated and confirmed by the organizer based on the order of receipt of full payment, booth numbers, booth type and line of business.

### 4. Use of Exhibition Space

- A. Exhibitors are bound to exhibit their announced products and services: and to staff the stand with competent personnel during the whole period of the exhibition.
- B. All exhibits must accord with the descriptions on the application form and be related to the theme of the exhibition.
- C. Public auctions without permission of the organizer are strictly prohibited. If the exhibitor violates the above mentioned rules, the organizer can stop the exhibitor's activity, remove his/her exhibits or order the dismantling of his/her booth. In this case, the payments made will not be refunded and the exhibitor is not entitled to claim for compensation.
- D. The organizer is entitled to restrict the entrance of particular individual(s) when deemed necessary.
- E. Exhibitors are not allowed to sublet their space(s) to other parties, either wholly or in part, without the written consent of the organizer.

### 6. Cancellation of Application

- A. In the event that the exhibitors decline to use the space allocated and/or not finalize the payment on time, the organizer can void the application. Deposits made in advance will not be refunded to the exhibitors.

### 7. Cancellation and Changes of the Exhibition

- A. In case the organizer cancels the African Business Opportunity & Investment Expo 2018 the payments made will be fully refunded.
- B. In case the exhibition is Reduced, Venue Changed and/or appointed to other dates due to force majeure, the organizer is not obliged to refund the payments to the exhibitors. The exhibitors, in this case, reserve no rights to claim the compensation.

- C. If the assembly is not completed on time, the exhibitors should get an approval from the organizer and make the payment for extra-hour usage to the organizer.
- D. Exhibitors have the duty to strictly adhere to the standards and specifics of booth construction stipulated by the organizer. Modification of exhibition booths (floor, ceiling, walls, pillars etc) is not allowed. The organizer reserves the rights to claim the compensation for damages to property.

**9. Removal of Exhibits and Stand Fittings**

- A. Exhibitors should remove all exhibits and stand fittings from the exhibition hall within the period stipulated by the organizer and indemnify the organizer against any cost incurred by reason of delay or damage to the exhibition hall.

**10. Securities, Risk and Insurance**

- A. The organizer will place securities for the safety of visitors and exhibitors.
- B. Exhibitors shall be responsible for insuring goods exhibited. The organizer shall not be liable for any damage or loss to exhibits and stand fittings.

**12. Supplementary Clauses**

- A. Whenever necessary, the organizer shall have the right to issue supplementary regulations in addition to above exhibition rules and regulations for the African Business Opportunity & Investment Expo 2018 to ensure the smooth management of the exhibition.

**13. Arbitration of Disputes**

- A. Any dispute, difference, or question which may arise at any time hereafter between the organizer and the exhibitor touching on the true construction of these terms and conditions for participation or the rights and liabilities of the parties hereto shall be finally settled by arbitration in accordance with the Commercial Arbitration Rules of the Ethiopian Commercial Arbitration Board in Addis Ababa, Ethiopia.
